APPLICATION TO SET ASIDE ORDER PROBATING WILL

TO THE HONORABLE JUDGE OF SAID COURT:

Bob Marshall Denison, Applicant, for the purpose of setting aside an Order of this Court probating a Will of Ida Baldwin Denison, Deceased, furnishes the following information to the Court:

I.

Applicant is interested in this Estate and is an individual domiciled in and residing at 663 Redwood Abilene, Taylor County, Texas, 79603.

II.

On August 26, 1997, this Court entered an Order admitting to probate a Will of Ida Baldwin Denison, Deceased, dated July 8, 1997, as the Last Will and Testament of Ida Baldwin Denison, Deceased, and authorized issuance of Letters Testamentary to John Wayne Denison, named in the Will as Independent Executor of the Estate.


IV.
