
ON THIS, the 18th day of June, 1997, came on to be heard the written application of IDA BALDWIN DENISON Rt. 1, Box 84, Old Glory, Texas, 79540, County of Stonewall, State of Texas, for the probate of the Last Will and Testament of BILLY WAYNE DENISON deceased, hereinafter called decedent, said will being dated August 14, 1989, which application is also for Letters of Testamentary; and due proof being taken in the manner required by law and it being proved to the satisfaction of this Court that this Court has jurisdiction and venue over this estate, proceeding and subject matter, and that every citation and notice required by law has been duly issued, served and returned in the manner and for the length of time required by law; and it appearing to the Court, after taking sworn testimony in open court, that the application heretofore filed in this cause complies with the Texas Probate Code and that all allegations contained therein are true; that said will of August 14, 1989, being self-proved in accordance with the Texas Probate Code, there being two subscribing witnesses to the will, Sharon Stanford and Sylvia Padron, of Jones County, Texas; and to the will there was attached a self-proving affidavit, being an acknowledgment of the Testatrix and an affidavit of the two witnesses; that the decedent died on or about May 24, 1997, in Stonewall County, Texas, and that four (4) years have not elapsed since the date of death of the decedent and filing of said application; that the decedent was, at the time of his death, a resident of and domiciled in Old Glory, County of Stonewall, State of Texas; that IDA BALDWIN DENISON named in said will as Independent Executrix, is not disqualified and is entitled to Letters Testamentary, that the decedent, at the time of the execution of said will was over the age of eighteen (18) years and was of sound mind, and that decedent executed said Last Will and Testament with the formalities and solemnities and under the circumstances required by law to make it a valid will, being self-proved in accordance with the provisions of the Texas Probate Code; that said will was not revoked by the decedent prior to his death; that the will is entitled to probate; and that all the necessary proof required for the probate of said will has been made; and that IDA BALDWIN DENISON, Rt. 1, Box 84, Old Glory, Texas, 79540, is named in said will as

Independent Executrix to serve without bond, and that such will provides that no action be had in the county court with respect to the settlement of such estate other than the probating of said will and the return of an inventory, appraisement and list of claims of said estate.

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court that said will on file herein is hereby admitted to probate and recorded as the Last Will and Testament of the said **BILLY WAYNE DENISON** deceased, and that such will, together with the application for probate thereof and all testimony in this proceeding, shall be and are ordered recorded in the minutes of this Court.

IT IS FURTHER ORDERED that the said **IDA BALDWIN DENISON**, receive Letters Testamentary upon taking the oath required by law and that no bond is required, and that when the said **IDA BALDWIN DENISON** shall have so qualified, the Clerk of this Court shall issue Letters Testamentary to her in accordance with this judgment.

The Court finds that it is not necessary to appoint appraisers.
